TERMS AND CONDITIONS

ADMISSION

Only application forms entirely filled and duly signed will be considered. If not accompanied by the payment of a deposit, application forms will not be registered. Notwithstanding the payment of the deposit, its invoicing and/or collection, admission of the applicant or his company is subject to a preliminary examination. In case of refusal, the applicant or his company will be notified by the Organizer and the deposit will be reimbursed. On the other hand, this sum collected from the Exhibitor remains the property of the Organizer if the applicant withdraws his participation (see withdrawal section). Admission is validated by means of an official notice from the Organizer or by the sending of an invoice, specifying the location, number and area of the stand. In this respect, given the limitations imposed by the placing of all the Exhibitors, **the Organizer reserves the right to modify the areas requested by the Exhibitor and the corresponding invoice by 20% without it being possible for the Exhibitor to cancel participation.** The Organizer is the only one to decide stand locations. Applications received after July 17th, 2009 must include the total payment incl. VAT, of the participation.

WITHDRAWAL

The signature of the application form is binding. Exhibitors must notify the Organizer of any withdrawal by registered post with acknowledgement of receipt. If withdrawal occurs before June 13th, 2009, the Exhibitor's deposit will be retained in compensation. If deposit has not been paid, the payment must be included in the withdrawal letter. If withdrawal occurs between June 14th, and August 13th, 2009, 50% of the total amount of the stand invoice will be owed in compensation. If withdrawal occurs August 14th, 2009 or afterwards, 100% of the stand invoice will be owed in compensation. This also applies if the Organizer is later able to rent stand space initially reserved for cancelling Exhibitor or if the Exhibitor does not occupy his place on the eve of the opening of the event.

RESPECT OF PAYMENT DEADLINES

No discount will be granted for advance payment. Failure to pay an invoice when it is due will entail the fines provided under Article L.441-6 of the French commercial law "Code de Commerce" at a rate amounting to twice the legal rate in force. Following allocation of the stand, the payment balance must be paid on or before the due date indicated on the invoice. In the case of non-payment of the balance by the due date, the Organizer reserves the right to utilize the stand space granted and/or will be entitled to prevent the exhibitor from occupying the reserved stand location; the total amount invoiced will remain due and payable to the Organizer.

INSURANCE CONDITIONS - WAIVER OF CLAIMS

Complete conditions of insurance appear in the Exhibitor's Guide, which will be available on www.equipauto.com website.

Insurance covers damages sustained by goods exhibited and any accidental damage of stand, namely for fire, explosion, theft with a deductible of 300 euros / claim, water damages, terrorism and sabotage, strikes, riots and civil commotions. The coverage applies to the stand, with a maximum of €763 per rented m² with a minimum of €15 260 € and a maximum of 229 000 €, which is a premium (administration fees included) of €3.51 VAT excl per m². **NB: This insurance does not cover the Exhibitor's third party liability, which remains at its cost.** If the value of goods exceeds the amount insured, a complementary insurance will also be proposed to Exhibitors, details will be given later in the Exhibitor's Guide available on www.equipauto.com website. **Plasma and LCD screens are excluded from the guarantee. The Exhibitor shall have the option of subscribing a special insurance about, which details will be given at a later date in the Exhibitor's Guide (complementary insurance form).** In case of an insured claim, losses will be completely covered within the limits of the amount insured, and this without any reduction of proportional rule (See insurance Conditions in the Exhibitor's Guide). The Exhibitors certify that the products or services presented comply with the safety standards imposed under the regulations in force, and accept full responsibility for possible defects in the aforesaid products or services, without implicating the responsibility of the Organizer.

EXHIBITOR'S GUIDE

All information and order forms concerning the details of the Exhibitor's participation in the exhibition will be provided to him in the "Exhibitor's Guide" available on www.equipauto.com website after the allocation of the stands (order forms for electricity, water, invitation cards, etc.) The Exhibitor also undertakes to abide by the insurance conditions, regulatory safety and prevention measures, customs formalities as well as instructions for the fitting of stands.

INTERNET SERVICES

The Exhibitor is solely responsible for the content of information supplied by himself and intended for online publication on the show's website, in particular, concerning products and/or services, characteristics, performance, prices, etc. The Exhibitor guarantees the Organizer the legal character of said information, particularly in the respect of legislation in force regarding the designation, offer, presentation, instructions for use, and description of the scope and conditions of warranty of the goods, products and services presented by the Exhibitor online, and more generally the respect of laws regarding advertising and consumer protection. The use of the French language is mandatory (legislation of August 4, 1994). Texts, logos, illustrations, photographs and visuals, products and brand names are published under the sole responsibility of the Exhibitor who alone bears possible rights of reproduction. The Exhibitor shall indemnify the Organizer against any third party out-of-court or legal claim.

SHOTS/BRANDS

The Exhibitor expressly authorizes the Organizer and its subsidiaries, free of charge:

- To take photos and/or make films, if he wishes so, representing him and the members of his team, as well as the products exhibited on his stand.
- To freely use these images on all media (particularly Internet), especially advertising media both in France and abroad and without any limitation in time.
- To quote and reproduce free of charge his brand or company name, as a business reference for his communication requirements, on all media (particularly Internet), in France and abroad, and this for a duration of five years from the signing of this document.

COUNTERFEIT

The exhibitor is directly responsible for the protection, intellectual or industrial, of materials, products, services and trade-marks displayed, in respect of the applicable rules and legislation. The Organizer cannot be held responsible for any dispute involving the above quoted topics, especially in case of litigation with another exhibitor or visitor. Should a counterfeit be stated by a Court, what ever the date is, the Organizer will be enforced to ask the exhibitor concerned to act so that he remains in ad equation with the judicial decision. Should however the conformity still not be respected, the Organizer keeps the right not to admit the Exhibitor, or to enforce adequate penalties, according to the present document, with no compensation or financial repair.

PENALTIES

In case of breach of the general Conditions and/or specifics regulations and/or general regulations, the Organizer will be entitled, after a formal notice if necessary in the presence of a bailiff, to proceed instantly to the closure of the stand and to forbid the exhibitor from entering it, without the exhibitor being able to claim any financial and material compensation in any form whatsoever from the Organizer. The costs incurred from the intervention of the Organizer (bailiff's fees and fees relating to the closure) will be payable by the exhibitor. In any assumption, at the time an infringement will have been noted, the Organizer will be authorised to cancel the contract without prejudice to damage which could be claimed. Pursuant to the above, the Organizer shall be entitled to refuse to admit the Exhibitor to all the fairs organised by COMEXPO Paris and its subsidiaries for a period of three years. **The provision of the general regulations of the "Foire, Salons et Congrès de France" (the text of which appears in the Exhibitor's Guide available on www.equipauto.com website), which are not contrary to the clauses of this application form and the exhibition's specific regulations shall remain applicable to Exhibitors at the exhibition.**

SPECIFIC REGULATIONS

ADMISSION

Only producers and importers are allowed to exhibit. Importers must include a certificate of representation rights (form enclosed) with their application to participate, from the manufacturer whose brands and products they represent at the show, allowing presenting them on the show. Any dispute with importers must be settled by the manufacturer, and no liability on the part of the Organizer can be sought. In the event that a brand on display is not mentioned in the certificate of representation rights, the Organizer will be entitled to invoice the Exhibitor for a penalty of 930 € VAT excl., and to have the products of the disputed brand removed from the stand. The products and services presented must be on the list established by the Organizer (see appended nomenclature and catalogue entry request). Registration fees amount to €650 by firm represented and €100 by brand represented from the 6th brand, the first five brands being free of charge. This fee allows a represented company to be included in the list of exhibitors and to include its registered office and stand number in the official show catalogue (refer to the attached Representation Certification form).

STAND PLACEMENT

The organizer draws the show plans and makes stand placements. Participation at previous editions of the show does not entitle Exhibitors to a particular stand location in his favour. Stand location attribution will be done according to the date of reception of application forms. Only those exhibitors having sent back their application forms before the 15th December 2009 will be invited to choose their stand placement. All the application forms received after this date will be placed automatically.

SUBLETTING - JOINT PARTICIPATION

Subletting or transfer free of charge to a third party of all or a part of a stand is forbidden. Any plan for joint participation at the same stand must be submitted for prior written approval to the Organizer. In the event that the Organizer accepts this plan, each company present at the stand must pay its own registration and insurance fees (Exhibitor's pack), that is 930 € VAT excl. If a company is present at a joint stand without having obtained prior permission from the Organizer, it can be excluded from the show without prior notice and without prejudice to any claim for damages.

DECORATION - INSTALLATION

The installation of a stand is exclusively incumbent on the Exhibitor, who can arrange the interior of his stand according to his own taste within the limits of the general regulations appearing in the Exhibitor Guide. You will find stand construction regulations in the "Exhibitor's Guide". Exhibitors must in this case present a stand design project for the Organizer's approval. Any breach of this obligation may lead to the immediate dismantling of the offending stand. In the event of an infringement, the Exhibitor undertakes to have the elements which are in breach of the accepted project removed at his own cost and risks. Failing this, the Organizer acts in place of the Exhibitor on the latter's responsibility and at his cost. Any deterioration caused by the Exhibitor's installations or exhibited goods to the building and installations provided by the Organizer, to the trees or the grounds, are evaluated by the Organizer's representatives and charged to the Exhibitor. The installation of the stands shall be fully terminated by the day before the opening so as to allow a check by the Safety Commission. The exhibition enclosure shall be closed to all vehicles the day before the show opens, the opening day and throughout the duration of the exhibition. The Organizer will only grant exceptions to these rules in case of absolute necessity. The spaces occupied by the stands must be fully cleared three days after the closing of the exhibition at the latest. The premises must be restored to their original state. It is recommended to provide for this clearing and restoration work in the contracts with firms engaged to erect and dismantle the stands.

STAND WITH A MEZZANINE

Any plans for installing a stand with a mezzanine MUST ABSOLUTELY be presented to the Organizer of the EQUIP AUTO 2009 Exhibition. The Exhibitor or the installer must submit an application including the calculations of a supervisory service. When assembly has been completed an on-site check and a technical report prepared by an approved organization are mandatory. These documents will be presented when the Safety Commission carries out inspection of the sites. Requirements: A minimum of 150m² on the ground. The surface area of the mezzanine must be equivalent to 1/3 of the ground surface. The maximum surface area permitted for a mezzanine is 300m². Only one level is permitted. Working weight: 250kg/m². Further details will be provided in the Exhibitor's Guide available on www.equipauto.com website.

Outdoor stands can be rented by an Exhibitor, on condition that he has already reserved a stand in a hall. (Exterior surface area must not exceed interior surface area). All unofficial demonstrations outside outdoor stands which have been authorized by the Organizer will entail closing the stand.
